## FORMS OF ASSISTANCE

### County Child Care Subsidy

Many local counties have child care assistance programs that they offer to subsidize working families in need of child care. As the YMCA is a licensed child care program through NYS Office



of Children and Family Services, our before & after school, vacation and summer day camp programs qualify for child care subsidies paid through the county. We currently accept subsidies for Madison, Oneida, Chenango and Onondaga Counties.

Families in need of Financial Assistance are encouraged to apply for county assistance before applying for YMCA Financial Assistance.

If you are currently receiving Department of Social Services temporary assistance, contact your caseworker to begin the child care assistance process.

If you are *not* currently receiving Department of Social Services benefits, contact your county's Department of Social Services Child Care Assistance division to apply.

### What if I don't qualify for a County Child Care Subsidy??

#### HOW DO I APPLY FOR Y FINANCIAL ASSISTANCE

1. Visit our website for a financial aid application at [www.ymcatrivalley.org](http://www.ymcatrivalley.org)
2. Complete the application and attach the required forms of income verification
3. Submit the application to the YMCA Front Desk along with copies of your income verification and a denial letter from the County DSS Office for child care subsidy benefits.
4. Your confidential application will be processed by the Program Director and an award amount will be given based on your income qualifications.
5. All Financial Assistance recipients must be YMCA members for approval. A Financial Assistance Membership Rate will be provided to you in your approval letter.
6. You will receive a letter in the mail stating the award amount you have received and how long your award is valid for. The approval process may take up to two weeks.

- **All Financial Assistance approvals are valid for one year.**
- **After one year, the applicant must reapply.**
- **Applicants are only eligible to apply for YMCA Scholarship Funding after they have been denied from County Child Care Subsidies.**
